## Dear Prime Minister

We are writing collectively as representatives of the organisations that will be most affected by the Government's newly announced 14-day quarantine for air passengers arriving into the UK.

We fully support the Government's commitment to public health and we are committed to playing our role to achieve this. At the same time, we have serious reservations about a blanket approach to all arrivals, irrespective of where passengers are originating from. This approach will have serious consequences for the UK's tourism & hospitality industries, and any sector of the economy which relies on air connectivity for their supply chains, recruitment and exports.

Rather, we ask Government to immediately look towards a more targeted, risk-based approach to screening of passengers, as happens with aviation security standards today. The Transport Secretary referenced the concept of "air bridges" in Parliament this week – a measure that would enable travel to countries which share commonality in country-wide health measures, screening standards in travel and /or low rates of transmission.

This proposal must be seen as a crucial step in the right direction. It would ensure we align with low-risk trading and tourism destinations right across the world, while shielding the public from high-risk countries. This approach is already being considered between Australia and New Zealand, and just this week, we saw Greece signal its intent to welcome back UK visitors from June. Europe's largest economy Germany has also said it intends to reopen its borders in less than a month.

We urgently ask the Government to set out how it will move to a more targeted approach, such as "air bridges", which would see the controlled reestablishment of air routes and overseas travel, where it is safe to do so, and as soon as possible to any low-risk country. The alternative risks major damage to the arteries of UK trade with key industry supply chains, whilst pushing the UK to the back of the queue as states begin conversations for opening up their borders.
